GENERAL MEMORANDUM OF UNDERSTANDING ON COOPERATION

BETWEEN

VINNYTSIA STATE MYKHAYLO KOTSYUBYNSKIY PEDAGOGICAL UNIVERSITY

AND

UNIVERSITY OF MICHIGAN IN ANN ARBOR, MICHIGAN, USA ADDICTION RESEARCH CENTER AND SUBSTANCE ABUSE PROGRAM

This Memorandum of Understanding ("MOU") is effective as of 2942017 ("Effective Date"), by and between Vinnytsia State Mykhaylo Kotsyubynskiy Pedagogical University and the University of Michigan in Ann Arbor, Michigan, USA and describes a collaboration to identify opportunities to enhance relations between the two institutions by developing academic and cultural interchange in teaching, research and other activities (the "Collaboration"). The parties acknowledge that this MOU is non-binding and that no legally binding obligations will be created with respect to the Collaboration described in this MOU until definitive agreements are executed and delivered by each party.

Within the framework of the regulations applying to each institution, and subject to the availability of resources, the following programs and activities will be encouraged:

- Joint research activities
- Joint educational activities
- · Joint conferences, seminars, symposia and other academic meetings
- Exchange of academic materials and information (e.g. exchange of publications, preprints text-books, teaching aids, etc.)
- Joint publications

The specific areas and details of cooperation within the framework of this agreement shall be discussed and agreed upon in writing by the appropriate authority of each institution, prior to the initiation of any particular program or activity.

The institutions acknowledge that in the absence of any specific agreement to the contrary, all expenses of salary, travel, living and allied costs will be determined at the discretion and be the responsibility of the visitor's home institution.

All visits of staff will be subject to compliance with entry and visa requirements of the two countries involved, and the requirements of the two institutions.

The agreement shall become effective from the date of the last signature and remain in force for a period of five (5) years with the understanding that it may be terminated by either party giving six months' notice to the other party in writing.

It may be extended by mutual consent of the two institutions, or amended by the exchange of letters signed by the parties' representatives.

The General Memorandum of Understanding is drawn up in two copies in English, each having the same force in law.
