AGREEMENT OF COOPERATION

Hereinafter referred to as the Parties

Content of the Agreement:

Object of the Agreement

§ 1

In the spirit of international cooperation beetwen partners and with an aim of mutual collaboration and assistance in attaining institutional goals, National Pedagogical University in Vinnitsa, Ukraine and Kujawy and Pomorze University in Bydgoszcz herein agree to sign a collaboration Agreement that will enable implementing statutory assingments of both partners as well as their other tasks resulting from the character of their activity.

§ 2

Agreeing parties shall develop cooperation in the field of scientific research, exchange of experience in didactics as well as joint educational, cultural, sport and business undertakings.

In particular the cooperation between partners will focus on:

- -increasing and proliferating achievements in science, national culture, sport and technology,
- -working for the benefit of local, regional and international communities,
- -the exchange of academic staff for the purpose of improving didactic processes through lectures and consultations,
- the exchange of academic staff with the aim of carrying out scientific research, developmental works, participation in scientific conferences and preparing joint publications etc.,
- -the exchange of and improving availability of library and data collections,
- -exchange of experience in the field of organization, methodology, science etc.,
- -creating favourable conditions for students', teachers' and administrative staff participation in organized presentations, scientific and practical conferences, seminars and other undertakings,
- -conducting joint educational and developmental projects.

§3

With the intention of effective cooperation both parties shall develop all traditional forms including organizing seminars, scientific conferences, exhibitions with the participation of interested organizations and companies.

§4

Specific terms of cooperation described in §2 and §3 shall be mutually agreed upon by both institutions on a case-by-case basic.

Rights and Responsibilities

§5

Specific terms of participation will be developed for each major activity implemented under the agreement. These terms will, when mutually agreed upon by both institutions, provide guidance for the day-to-day operation of activities. All activities entered into as a part of this agreement will be implemented on a funding available basis.

§6

Parties shall act according to the Agreement as far as the proliferation and publication of the research results is concerned. The same applies to the scientific results, information, documentation, experiments that are confidential according to the Agreement. Publications as well as other forms of disseminating research results require written consent of the party who owns the copyright law, or both parties in case publications or research outcomes result from the agreement between the parties.

The Agreement shall not interfere with and shall not exclude other forms of cooperation with third parties.

Terms of Validity and Changes

§8

The Agreement is signed for an unspecific period of time. Either party may withdraw from this Agreement on giving to the other no less than three months' prior written notice. In that case the termination of the Agreement is effective at the end of the given academic year other than in regard to any matter which is so central to the matters referred to in this Agreement or to the reputation of either party when notice of termination may be given in writing at any time by one party to the other.

This Agreement has been drawn up in 4 identical copies in Ukrainian and English (two for each part) and is equally biding for both parties.
